Wanderweg Holidays Booking Conditions & General Information

*Please ensure that you understand and accept the following conditions & information.
NB during the Covid situation worldwide we will treat all booking changes and cancellations sympathetically and on individual basis.*

Payment:

1. A deposit of 25% of total tour cost per person is required at time of confirmation of booking. Payment of this indicates acceptance of the terms & conditions of Wanderweg Holidays.
2. Final payment is due 60 days before commencement of tour.
3. Late bookings will be accepted if accompanied by full payment.
4. Once a booking has been confirmed & full payment made Wanderweg Holidays will guarantee to hold that price against currency fluctuations.

Cancellation charges: If written cancellation is received:

More than 60 days prior to commencement.....10% of tour cost

35 - 59 days..... 30% ,,

8 – 34 days..... 60% ,,

7 days or less..... 100% ,,

Amendments to confirmed arrangements will incur a charge of \$80 per tour booking

Tour Costs: Prices are per person in Australian dollars based on the exchange rate prevailing at the time of quoting & are subject to change in case of more than 3% fluctuation either way. See “payment 4”

Not included in costs: Passports, visas, insurance, meals other than specified, drinks, items of a personal nature or any other charge not listed as an inclusion. e.g. entry fees

Insurance: It is a condition of acceptance of a booking by Wanderweg Holidays that adequate travel insurance be taken to cover against such things as cancellation charges, medical & additional expenses, personal accident, loss, theft or damage to baggage & travel documents & personal liability.

Documentation: It is the responsibility of each person departing from Australia or elsewhere to carry a valid passport & visas as required.

Travel documentation relating to all aspects of Covid 19 worldwide is the responsibility of each individual traveller

Responsibility: Wanderweg Holidays gives notice that it acts as a booking agent only for the persons or companies providing or offering the means to travel conveyance, transport, accommodation or other services & all tickets, vouchers, exchange orders are issued subject to the terms & conditions under which such transportation & other services are provided. Wanderweg Holidays shall not be liable for any injury, damage, loss, accident, delay or irregularity that may be caused or arising during any tour sold. The right is reserved to modify the itinerary in any way considered necessary or desirable, to change any reservation and/or means of conveyance. The right is also reserved to cancel or withdraw any tour or any booking made for a passenger or to decline to accept or retain any person as a member of a tour for any reason whatsoever. No refunds will be made for included tours & sightseeing excursions not undertaken. The transportation companies or firms shall be exempt from all liability in respect of any detention, loss, damage, sickness or injury however & by whomsoever caused & of whatever kind occurring to the passenger at any time the passenger is not on board a carrier or conveyance used or operated by the relevant transportation companies or firms & the purchaser of these tours.
